

<u>The Pandemic – A Pathway to Progress</u> *A think piece*

Kālchakra, the word used by our forefathers to describe time as a wheel, commenced at the beginning of the Universe, fierce and unstoppable. The modern-day man views this very time as money; and why should he not? Years spent in the classroom resulting in decades of office work comprises a lifetime, rather generations spent in chasing money.

During this incessant pursuit of ambition, there come these sporadic halts in the kālchakra, that devastate the whole of mankind, making them question the very reality of their existence. One such pause is the coronavirus pandemic of 2020. A 100 nanometric microorganism affecting 40 million lives, bringing the \$142 trillion world economy to a standstill.

During the lockdown, 18.9 million salaried people in India lost employment while many others faced reduced salaries. As CRISIL warned us of the worst recession since independence, SBI estimated a 40% GDP contraction in Q1. The impact was unanimously a deep wound – psychologically and economically.

In such distress, a faint voice of hope comes to me in the works of prominent economists, Douglass North, Branko Milanovic or even the famed Keynes who'd agree with me if I were to say 'Destruction paves the path to progress.' You may find Japan a stirring example, though bombed during the Second World War, not only did it recover – it developed, exponentially!

If we aspire to call ourselves a developed nation someday, then it is now that we must act. Prudent policy measures on the government's part are sufficient to recover. However, considering the pandemic an infection to be cured from, rather than a once in a lifetime opportunity, would be unfortunate.

Calling the present scenario a Bretton Woods moment, IMF MD Kristalina Georgieva called for a boost in human and physical capital to underpin growth and resilience. As India launches its National Education Policy and attempts to resolve supply-side constraints through progress on labour reform bills and the farm bills; the government bodies and private players of India would still miss the golden opportunity if they failed to capitalise on the current global trade scenario.

While the government and firms struggle, a nation is made of its people. As lockdown restrictions are slowly uplifted, and the wheel of time prepares to resume at full force; the common man will soon be faced with a choice – whether to go back to the ways of the past, or to reach a new level of efficiency.

A recessionary environment calls for the survival of the fittest, thereby

necessitating the latter. Utilise this time you have been granted, carefully. Steer away from hysteresis and stagnation. Explore your potential – learn, consider entrepreneurship opportunities, career path shifts. Embrace technology. Seek knowledge and guidance from your close ones. Be ready to jump back into the world – hopefully, as a new and improved you.

<u>US Presidential Elections 2020: Impact on</u> <u>the Indian Economy</u>

Stock Market

- Biden: In the case that Biden wins and democrats seize both houses of Congress, it is likely that the US Corporate Taxes will increase on the companies and will have a decrease in the net profits of the companies which will have a negative effect on the growth stocks like tech stocks. This will give a surge in the value stocks like FMCG, traditional Banks, etc. This will also change the sector allocation from non-green stocks to green stocks, more of essential company stocks. Even the country asset allocation will change for the foreign investors since for them now APAC stocks will be attractive for them and this will actually increase the passive flows to India which will have an increase in the weights of the emerging market indexes like MSCI, S&P, etc.
- *Trump:* If Trump wins, the government won't increase corporate taxes and this will be a huge win for stocks. Even in the present scenario, value stocks are not performing well under the Trump administration. The country allocation of foreign investors would change since US stocks are much more attractive for them and US stocks will benefit much more when the yields of the T-Bills are low. The Asian stocks might also benefit since the trade war might

prolong and which will benefit the Indian markets.

Hence, irrespective of whoever wins Indian stock market has good growth in the future.



Climate Change

• *Biden:* He had written that when he would be the president, one of his initial tasks would be to join the Paris Climate Agreement. His aim is to achieve net-zero emissions by 2050. India, which is severely impacted by climate change, has an opportunity in the Biden administration to make more green technology partnerships which will help in building the new supply chain arrangement for the green technology sector. This will incentivise India to adopt a new climate resilience strategy which it currently does not have. For foreign investors, this would be an investment opportunity in India because India is one of the largest carbon emissions emitters.

• • Trump: Trump favours policies towards the oil and gas sector in terms of easing the regulation and not incentivising the power companies to shift away from coal. He also does not support the Paris Climate Agreement. If Trump wins it is a great getaway for the Oil and Gas industry who are the most contributors to climate change and planning to build 157 new or expanded plants which will increase GHG pollution manifoldly. Due to these liberal policies on climate change, countries like India will not be incentivised to adopt renewable energy and also it might increase the fossil fuel subsidies to all these companies which will be difficult to mitigate the climate change in India.

Global Gold Market

Well, there are many scenarios for gold and it is difficult to say whether the gold prices would increase or decrease. Gold prices forecast for 2020 is \$1600 an ounce. But gold prices are negatively correlated with the dollar prices. If the Feds T-bills yield continues to trade around 1% to 3% for 30-year bills, a selloff may occur from other countries and thus weakening the dollar prices and causing surging the gold prices.

- Biden: He has pledged to reverse many of the current Trump policies if he wins the election and this could possibly remove uncertainty in markets as behaviour and policies are more predictable and Biden has an anti-mining policy which will be bad for gold. But policies are towards providing a lot of fiscal stimulus in various sectors ranging from plans on spending \$1.7 trillion dollars for combating climate change and providing sustainable infrastructure, healthcare, education, automobile, clean energy, housing and agriculture & innovation. This will have an increase in the debt to GDP ratio and weaken the dollar prices which will increase the gold prices. Hence, the non-favouring of gold by Biden will decrease the prices but his policies might provoke the gold prices to increase.
- *Trump:* His actions have added to the appeal of gold as a safe-haven asset. Some things that have supported gold this year are certainly not Trump-specific. Uncertainty over China relations and the strong belief that sanctions should remain on Iran are clearly supportive of gold prices as geopolitics. China being the largest holder of Fed T-bills, may start a sell-off if they want to increase liquidity. This can also weaken the dollar and cause gold to surge.

How *would have* Biden and Trump affect the Indian stock market? What do you think?

<u>A Fetching Protest</u>

21st century India has a dominant agrarian society which employs 43% of Indian workforce, is the primary source of livelihood for 58% of the population, and accounts for 16.5% of India's GDP. India is the 2nd largest producer of Bamboo, fruits, and vegetables and 9th largest exporter of agricultural products. During 2019-20* crop year, food grain production was estimated to reach a record 295.67 million tonnes (MT). Agricultural export from India reached US\$ 38.54 billion in FY19 and US\$ 28.93 billion in FY20 (till January 2020).

The new farm laws were introduced on September 14th and passed by both houses of Parliament by September 20th, 2020. Today we see the farmers protesting and demanding the laws be repealed. It is worth noting that agriculture is a State subject, and the Union Government can only provide guidelines: States have the power to decide whether to make amendments or not. What are the laws and how do they affect the farmers? Has the government not done anything for the farmers and is only catering to the crony corporates? Is this truly a Suit-Boot government?

Let us take a leaf out of history to see how the Agricultural Produce Market Committee (APMC) first came to existence. In 1886, under the Hyderabad Residency Order, the first regulated market was established. This was followed with the Berar Cotton and Grain Market Act of 1887, which empowered British Residents to declare any place in the assigned district a market for sale and purchase of agricultural produce and constitute a committee to supervise the regulated markets. Raw cotton was amongst the first goods to be regulated which were purchased locally at minimum price for the Mills of Manchester that produced clothes to be sold back in India for a profit. Post independence, by the 1960-1970s most states implemented their own forms of APMC Acts. Acts allowed States to set up and regulate marketing practices in wholesale markets. Under the act, the state Government could only set up markets, thus preventing private players from setting up markets and investing in marketing infrastructure. This led to the formation of cartels with links to caste and political networks resulting in price variations and an increased number of middlemen formed a virtual barrier between the farmer and the consumer. This has led to the consideration of improving the situation for farmers through various schemes.

It is worth knowing some of the key schemes the current government has introduced and the benefits of said schemes to the farmers. These include:

1. eNAM

- It is a pan India electronic trading portal which networks the existing APMC mandis to create a unified national market for agricultural commodities
- Small Farmers Agribusiness Consortium (SFAC) is the lead agency for implementing eNAM under the aegis of Ministry of Agriculture and Farmers' Welfare, Government of India.

2. National Mission for Sustainable Agriculture (NMSA)

- Enhancing agricultural productivity especially in rain fed areas focusing on integrated farming, water use efficiency, soil health management and synergising resource conservation.
- Some schemes under NMSA include:
 - A. National Centre of Organic Farming (NCOF): Being implemented by INM Division.
 - B. Central Fertiliser Quality Control and Training Institute (CFQC&TI): implemented by INM.

3. Pradhan Mantri Krishi Sinchai Yojana (PMKSY)

- Focuses on water conservation and water management
- Vision of "Har Khet Ko Pani"

4. Pradhan Mantri Fasal Bima Yojana (PMFBY)

- Government sponsored crop insurance scheme
- To provide insurance coverage and financial support to the farmers in the

- event of failure of any of the notified crop as a result of natural calamities, pests & diseases
- To stabilise the income of farmers to ensure their continuance in farming
- To encourage farmers to adopt innovative and modern agricultural practices
- To ensure flow of credit to the agriculture sector

5. Gramin Bhandaran Yojana (GBY)

- Create scientific storage capacity with allied facilities in rural areas
- To meet the requirements of farmers for storing farm produce, processed farm produce and agricultural inputs
- Promotion of grading, standardization and quality control of agricultural produce to improve their marketability
- Provide warehouse subsidy to store reserves

These are of course only a few schemes that try to ease the pains of the farmer. This brings us to the vital question of what are the new farm laws and what do they propose. Let's first look at the **The Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Bill, 2020**. The bill aims to explain three areas: farming agreement, pricing of farming produce, and dispute settlement.

1. Farming Agreement:

• The Ordinance provides for a farming agreement between a farmer and a buyer prior to the production or rearing of any farm produce

- The minimum period of an agreement will be one crop season, or one production cycle of livestock
- The maximum period is five years, unless the production cycle is more than five years

- 2. Pricing of Farming Produce:Pricing must be mentioned in the contract
- Process of price determination must be mentioned in the contract
- A price guarantee must be agreed upon and any variation must have a minimum guarantee

3. Dispute Settlement:

- No action can be taken against the agricultural land of the farmer for recovery of any dues
- Calls for formation of a conciliation board and conciliation process for settlements and disputes and disputes head to the Board first
- If no resolution from The Board in 30 days, the matter is taken with the Sub-**Divisional Magistrate**
- Both parties will have the right to appeal to an Appellate Authority, Collector or Addl. Collector, against decision of the Magistrate

The second bill introduced was the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Bill, 2020. Let's look at the areas the key highlights of the bill. The Ordinance allows intra-state and inter-state trade of farmers' produce outside:

- The physical premises of market yards run by market committees formed under the state APMC Acts and
- Other markets are notified under the state APMC Acts.

Such trade can be conducted in an 'outside trade area', i.e., any place of production, collection, and aggregation of farmers' produce including:

- Farm gates
- Factory premises
- Warehouses
- Silos
- Cold storages

Lastly, let's look at the Essential Commodities (Amendment) Bill, 2020 and its highlights. Essential Commodities Act, 1955 empowers the central government to designate certain commodities (such as food items, fertilizers, and petroleum products) as essential commodities

1. The Ordinance provides that the central government may regulate the supply of certain food items including cereals, pulses, potatoes, onions, edible oilseeds, and oils, only under extraordinary circumstances like:

- War
- Famine
- Extraordinary price rise
- Natural calamity of grave nature

2. It requires that an imposition of any stock limit on agricultural produce must be based on price rise.

3. A stock limit may be imposed only if there is:

- 100% increase in retail price of horticultural produce
- 50% increase in the retail price of nonperishable agricultural food items

4. The increase will be calculated over the price prevailing immediately preceding

twelve months, or the average retail price of the last five years, whichever is lower.

So why are the farmers, the food providers, protesting against these laws. Farmers fears that Much of government procurement at minimum support prices (MSP) — of paddy, wheat and increasingly pulses, cotton, groundnut and mustard — happens in APMC mandis. Much of government procurement at MSP include:

- Paddy
- Wheat and increasingly pulses
- Cotton
- Groundnut
- Mustard

Thus, if the government stops buying, farmers will be left with only the big corporates to sell too. Another concern is the way production agreement is defined has led to fear among farmers about contract farming being more about corporate farming. The Act clearly says that farmer land can't be leased, mortgaged or bought by the contracting agency which contradicts the claim of the protestors that claim farmers will lose their land. Another fear is of contract farming. The fear is of:

- The problems they face include highly one-sided (pro-contracting agency) contracts
- delayed payments
- undue rejections
- outright cheating besides poor enforcement of contract farming regulation by the state governments

Lastly, with amendments to the Essential Commodities Act, farmers fear that the government procurement for extra crops will not take place thus leaving them with a surplus of grains. As a result, the farmers:

- demand to repeal all three laws
- demand for a law guaranteeing of MSP
- reverse all penalties on farmers for cropresidue burning under a new antipollution ordinance promulgated in October
- review of a bill that provides for direct cash payments to farmers to offset costs of electricity for farming in lieu of the existing practice of providing subsidised power supply
- Addition of the Civil Courts and not the Sub-Divisional Magistrate or District Collector
- Implementation of Swaminathan Commission report to fix MSP with C2+50 percent formulae
 - A. Cost C2 the Comprehensive cost (cost C2), it includes imputed costs of family labour, imputed rent of owned land and imputed interest on owned capital.
 - B. 50 per cent margin over C2, which is also being the demand of the farmers.

Now the three laws seem to liberalise the APMC from cartels and commission agents who have reaped the benefits from the farmers for over 60 years. With this the farmer has the ability to sell his/her

produce pan India as to get the fair price. They are not restricted to only sell in the APMC mandi but also the private mandis'. What's interesting is the demand for the direct cash transfer for the cost of electricity. As a future tax payer, I find it necessary to ask as to why taxpayer money should be used to pay for electricity for farmers and not for the development of government schools, hospitals, and infrastructure. It is important to note that income earned on farming is tax free so why the need for an extra cash transfer? Lastly, as we saw during the peak of the global lockdown, nature began to come alive. We saw how rivers, oceans, and even the air we breathe become clean. It is vital to protect our environment and thus laws must be implemented to address the issue of stubble burning. Every year the National Capital Region (NCR) and its adjoining areas are choked due to stubble burning. This is a time of change and change is the only constant.

With change comes innovation and we see it on a daily basis. From cycling to electric cars, humanity has come a long way. Artificial intelligence is making work earlier seen long and arduous now seem like a piece of cake. This is the time to bring AI to farming and agriculture With the help of AI, farmers can now analyse a variety of things in real time such as weather conditions, temperature, water usage and soil conditions collected from their farm to better inform their decisions.

Farmers are also using AI to create seasonal forecasting. It is particularly valuable for small farms in developing countries as their data and knowledge can be limited and by keeping these small farms operational and growing bountiful yields is important as these small farms produce 70% of the world's crops.

Of course the bill has some drawbacks which must be solved through dialogue. Both parties must approach the matter diplomatically since food security is vital for achieving a \$5 trillion economy. The 21st century will see the rise of India on the global stage and for that it must be a country of dialogue. We are a vibrant democracy and this is what will make India the leader of the post-COVID world.

<u>Delving into the technology of the future-</u> <u>Neuralink</u>

So, what's to be seen in the near future? How is the next decade going to shape up? Will there be more unemployment? Will robots take over? I think we all have had the same questions in our mind for sure. We have come a long way in the world of science and every day, there are new inventions and innovations being made somewhere in the world. The constant process of improving tech and tools for solving our day to day problems and inconveniences has led us to where we are at this very moment.

So, the real-life Tony Stark, as I like to call him - Elon Musk has been quite busy in getting all the attention with his tech companies such as Tesla Motors, SpaceX, the Open AI Foundation and the Neuralink Corporation. We're quite acquainted with Tesla Motors and their selfdriving mechanism as well as the astronomical research at SpaceX. We're well aware about the potential of EVs and hence we're witnessing the Tesla stock prices surge. However, Neuralink is something that will astonish everybody. We've all seen cyborgs in movies and games, and this is as close as it gets to it.

So, let's talk about what Neuralink is.

Neuralink is a fully integrated brain machine interface (BMI) system. These systems form a connection between the computer and the brain. The neurons in our brain are the carriers of signals, and they also receive information. They form a neural network consisting of about 86 billion neurons! Now, that's a BIG number. The neural threads or electrodes are used to detect these signals and then these signals are transferred to the chip which processes them into the computer. These neural threads are embedded

using a special automated surgical robot as it requires high precision.

So far, the Neuralink corporation has managed to fit in 1024 electrodes in the current model. The electrodes used over here are about 800 times smaller than the ones used in a few BMIs that are currently available with much lesser electrodes than the Neuralink. We can say that with the flow of time, everything will definitely improve and gain more precision. The operation is quite expensive at the moment but that's common for any new technology and it will become less expensive and widely available over time.

What is the main challenge that lies ahead? Neural spikes contain a lot of information, and that information needs to be decoded for controlling a device such as a computer. As per the company's website, the academic labs have designed computer algorithms controlling a virtual computer mouse from the activity of hundreds of neurons. With more electrodes. Neuralink has the ability to include additional devices such as a keyboard and a game controller and for this, they are working on recent advances in statistics and algorithm designs. Their aim is to infuse artificial intelligence in these algorithms so that they continue to improve and be more adaptive and robust over time.

The objectives in the short term are to help patients with severe spinal

cord injuries by giving them the ability to control computers and mobiles directly through their brains which basically means converting their thoughts into actions. Many future applications include restoring motor and sensory functions and the treatment of neurological disorders such as Alzheimer's. There are many hindrances that disable people face while communicating themselves to the world. This device will improve many lives and definitely make a difference. It will help people gain something important which they might have lost and give them hope for leading a better life.

No one knows what might happen in the future. It is in the hands of the humans to have a control over inventions like these, which can certainly bring a shining light in someone's life or create menace if utilised wrongly. This is just a glimpse of it and there's a lot more to be found. We're moving towards a world that would be much more connected and efficient and with the hope that the future is brighter than ever.
